**Full Term:** \$4,200.00 plus \$252.00 State Sales Tax = **\$4,452.00**  
**One Term:** \$2,700.00 plus \$162.00 State Sales Tax. = **\$2,862.00**

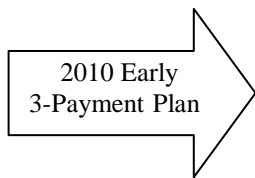
### 2010 Early Payment Rates (rates expire December 1, 2009)

**Full Term:** \$3,948.00 plus \$236.88 State Sales Tax = **\$4,184.88**  
**One Term:** \$2,538.00 plus \$152.28 State Sales Tax = **\$2,690.28**

*\*State Consumers' Sales Tax of 6% has been added to each fee under West Virginia State Law.  
\*Both fees are designed to cover all expenses at camp except medication and other incidentals. The store accounts are not included in the camp fee.*

### PAYMENT POLICY

1. To secure the reduced rate, you must register your daughter by December 1, 2009 by either making a lump-sum payment or *at least one* payment by that date. Payment must be *received* or *post-marked* by December 1, 2009. **No exceptions will be made for late payments.**
2. 3-Payment Plan: Payment due dates and amounts are listed below. Please send the initial payment along with the application. We will send you reminders in January and April for the other two payments.
3. **Failure to remit each regular payment forfeits the discount.** In the event of failure to continue payments regularly, the amount already paid will be credited to the camp fee and the full camp rate must be paid.
4. **A 3% service charge will be applied to all unpaid balances after June 1, 2010.**

### REFUND POLICY

1. Withdrawal prior to May 1, 2010: all payments **less a \$100.00 administrative fee** will be refunded
2. Withdrawal after May 1, 2010, *for reasons other than illness*: a \$150.00 fee will be charged
3. Withdrawal after June 1, 2010, *for reasons other than illness*: the full fee will be charged
